

Charter of «Grandes Écoles Pour la Paix»

The GE2P Label "Grandes Écoles Pour la Paix" was created to distinguish and enhance establishments of higher education which undertake to:

> Sensitize the youth students to the primordial values of peace, tolerance, understanding, equality and cooperation between people, in order to reduce obstacles and threats to peace and progress in the world.

> Educate and train students for Peace through Education, learning, research and the dissemination of elements relating to the knowledge and Peace's exercise.

> Exert a positive influence on youth students through actions that will have a concrete impact on their environment, at local, national and international levels.

> Implement the GE2P action program, aimed at creating, developing and perpetuating a climate of peace within their Campuses and in their respective territories and countries.

The 20 constituent commitments of the GE2P Charter

Societal, institutional and political actions

• Advocate a peaceful behavior, of mutual understanding and reciprocal comprehension, respectful of the rights of all the actors of a school community, this in order to establish and maintain a climate favorable to the development of peaceful "normalized" relations;

• Integrate the principles of equality and non-discrimination into the policies and administrative practices of establishments;

• Manage conflicts while respecting the rights and dignity of all stakeholders;

• Take concrete action against all forms of racism, anti-Semitism and hatred;

• Collaborate and work in concert with governmental and non-governmental organizations and institutions working in the fields of education and peace.

Actions relating to education, teaching and training, the student journey ...

• Propose and implement training programs and thematic workshops on peace, tolerance, global ethics.

• Build on the knowledge and skills acquired by some communities of the world who have integrated into their systems of social relations, peaceful and non-violent methods of handling and resolving conflicts.

• Integrate into students' journeys and pathways the understanding of major concepts and challenges in terms of Peace, Human Rights and Social Justice;

• Use teaching and learning methods that encourage participation, exchange, cooperation, problem solving and respect for differences; Offer teachers seminars and teaching aids in the fields of peace, justice, human rights, equity and social progress;

• Host a minimum quota of 15% of international students within its Institution;

For the label GE2P - "Grandes École Pour la Paix", ECAM-EPMI General Manager, A-M Darcherif: • Organize seminars and symposia on the themes of peace, racism and anti-Semitism;

• Collaborate with other schools, universities and research organizations in processes aimed at integrating the values of peace, tolerance, "living together" but also those of Social and Environmental Responsibility, and this in all forms and at all stages of education.

• Encourage and support student projects that are in line with the values set out in the GE2P Charterdes valeurs énoncées dans la Charte GE2P.

International Actions

• Carry out international actions in favor of peace and understanding between students of all origins and from all countries;

• Collaborate with international organizations and institutions, within the framework of all initiatives and actions in favor of education and peace;

• Encourage and promote the international mobility of students by any means available (study and / or research programs, exchange agreements, scholarships, endowments, etc.).

• Develop exchanges and partnerships between the Schools adhering to the GE2P label, on an international level.

Marketing and Communication's Actions

• Use only the documents and communication media made available by GE2P Label's organization for members (logo, language elements, brochures, website, etc.);

• Communicate on the actions carried out and relay the communications emanating from the GE2P Label, via the websites and social pages of the GE2P Label members.
